Normally this document is completed in the spring after the budget, but the state has a new format. The two big expenditures from LCFF and Title I are the continuation of the 3 day a week guidance assistant and the Arts Education Project for student VAPA experiences while teachers are released for PLCs just about twice a month. The release time allows for teacher collaboration time and for assessment monitoring. As a district we have a focus on ELs and students with disabilities, so additional data is called out with specific goals created for those subgroups. We are also a STEAM school, so there is a new section to address our STEAM work. • 2019-2020 SPSA approved
